## 3.0 Supporting and Engaging Students

### 3.1 Induction Programmes:

• **Student** induction will be tailored to reflect students' mode of study (blended, online or face-to-face), providing guidance on navigating both physical and digital learning environments. The programme will ensure students are familiar with key online platforms and support resources .

#### **3.2 Academic Skills Integration:**

• The development of academic skills such as literacy, numeracy, and digital literacy will be integrated across all stages of the learner's programme, with increased focus on early intervention to diagnose and support individual learning needs.

### 4.0 Using TEL

#### 4.1 Strategic Aim:

We aim to fully utilise digital technologies and infrastructure to enhance learning within and beyond the classroom, while also supporting sustainability goals through reduced reliance on physical resources.

#### 4.2 Technology Infrastructure and Support:

- This policy will ensure continuous upgrading of IT infrastructure to support high-quality learning experiences. Both staff and students will receive adequate training to make effective use of digital resources, including virtual learning environments (VLEs), collaborative tools, and online assessments.
- Assistive Technology: MIE will explore the use of assistive technologies to enhance the accessibility of learning materials and online content for students with disabilities .
